#### 9-1-1 Report to Commissioners, 5/8/2023

- Have held multiple discussions with ComTech, Ohio 9-1-1 office and partner counties regarding the system bridge solution to extend the useful life of the core in the SOCC. All partners I have spoken with are in favor of the \$29,820.89 proposal. I am waiting on a cost certain document at which time I will prepare MOAs and have the Prosecutor review. As previously reported, we have to pay the initial bill as we hold the contract with ComTech, but our final cost will be \$4970.15 after recovery from partner counties. I remain unsure what we will do if any of the counties refuses to accept and pay for the bridge solution.
- Have also held several discussions with partner counties regarding charges for prior years. I have requested invoices from ComTech showing the breakdown of our annual invoices splitting out the costs related to the core at the SOCC and our PSAP costs.

- Still working on the Federal Communications Commission (FCC), National 9-1-1
   Program Office report that is due May 22<sup>nd</sup>.
- As previously reported, we need to aggressively pursue having qualified personnel only in call-taking positions, particularly for EMD. I am unsure how to go about this as I do not control either PSAP's personnel. The Sheriff is working on having all of his call-taker/dispatcher personnel certified, M&M does not appear to be doing so, and that is where the need is most critical due to State law. The shortest paths towards compliance appear to be; 1) Sheriff's personnel being sole call-takers, relaying information for fire or EMS calls to M&M, who would just serve as dispatchers, or, 2) Placing a County employee (Sheriff's call-taker) in the M&M radio room to take transfers from SO for fire and EMS calls. Neither of these proposals are ideal and frankly, are wrought with issues.
- There are continued issues with MARCS radio coverage in the county. There is
  apparently a proposal for a new, alternative radio system being put together by Randy
  Bebout representing M&M Fire Department. This would entail totally new infrastructure
  and radios. While I welcome the initiative, I question the viability of such a proposal as it
  would be quite costly and funding is questionable unless it complies with the Ohio SCIP
  (Statewide Communication Interoperability Plan) and SAFECOM. Obviously, the State
  of Ohio is all-in on MARCS radio for LMR (land mobile radio) and any system will have
  to have interoperability with the MARCS system. I believe our focus should be on
  working with the State to improve MARCS services.
- As both 9-1-1 and LMR are within the purview of the SCIP, I would like for our next step to be convene the 9-1-1 Steering committee to address these issues and formulate a plan to move forward.
