On September 14th there was a Junior Fair wrap up meeting with the Junior Fair Board and Sale Committee to discuss the positives and negatives of the 2023 Morgan County Junior Fair. -The Village of Stockport was awarded a \$500,000.00 critical infrastructure grant from Ohio Department of Development for a sewer line replacement project. The project will replace existing outdated gravity sewer mains which larger lines that can safely handle the increased sewer flow. It is \$1,200,000.00 total project with the remaining funding coming from the Ohio EPA and Ohio Public Works Commission.

Ohio Department of Development announced House Bill 33 has budgeted \$350 million (\$175 million for Fiscal Years 2024 and 2025, respectfully) in grant money to the Ohio Department of Development's Bloomfield Remediation Program and \$150 million (FY24) TO THE Demolition Site Revitalization Program. A notice of intent is request to identify a lead entity for administering these programs for the county.

Bobby White, Mobility Manager and John Sampson, Morgan County Public Transit are attending the Ohio Public Transit Association conference in Columbus this week on behalf of Morgan County.

The lampposts were ordered on September 15, 2023 for the Grove park project and should take about two weeks to arrive. Meetings were held last week to discuss coordination between the sidewalk contractor and the electrician.
