- Working with Jesse Owens State Park manager Ron Mingus, and ODNR Wildlife regarding dispatchable addresses and road centerlines for park/wildlife areas.

- Telecommunicator training and EMD dispatching are at a critical juncture. We need to discuss immediate solutions as M&M does not feel they need to have trained personnel or perform EMD with pre-arrival instructions.

-Chris Helle, Office Manager for Morgan County Public Transit has started employment effective today, September 25, 2023.

Mrs. Wells will submit documentation for the Morgan County Development Office to be the lead entity for the next round of Brownfield and Demolition funds available from Ohio Department of Development. A request of proposals may be considered for consultant assistance to identify brownfield/demolition projects to submit for the next round.

A possible grant opportunity, named Rural Reimagined EV Charging Network Program, sponsored by Tennessee Tech could allow for Morgan County to be granted one EV charging station. The agreement has been sent to the prosecuting attorneys office for review. Installation costs and maintenance costs would be county responsibility. A partnership with a village may need considered to manage the charging station.

Quotes are due October 2, 2023 for the demolition of 1:30 4^{th} Street Malta, Ohio. No contractors attended the pre-bid scheduled last week.

A nomination form has been completed for \$150,000.00 of Household Sewage Treatment funds from the Ohio EPA for 2024.Commissioner signature requested.
