FINAL RESOLUTION

The following Final Resolution enacted by the Board of County Commissioners, County of **Morgan**, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on **21st day of August 2023**, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of widening S.R. 60 and adding a middle turn lane from S.L.M 14.11-14.52 (North of McConnelsville), including drainage upgrades and pavement markings, lying within Morgan County; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The County agrees to assume and bear a lump sum amount of Eight Hundred Forty-Five Thousand Six Hundred Ninety-Two and - - - 00/100 Dollars, (\$845,692.00).

The share of the cost of the LPA is now in the amount of Eight Hundred Forty-Five Thousand Six Hundred Ninety-Two and - - - - 00/100 Dollars, (\$845,692.00); and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, be it resolved:

- I. That the sum, of Eight Hundred Forty-Five Thousand Six Hundred Ninety-Two and - 00/100 Dollars, (\$845,692.00) is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from State funds.
- II. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.
- III. That the LPA enter into a contract with the State, and that the Vice-President of the Board be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.
- IV. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.
